SDT will supply one or more First Aid Kits and Fire Extinguishers (with current safety check stamp) of sufficient size and quantity for the expected participant numbers. We do not rely on equipment to be available at the venue nor to be provided by the organisation or school attending our training.

VEHICLES USED FOR TRAINING

During practical driver training, mechanical failure and tyre failure are risks that require planning and management. In particular, low tyre pressure can cause tyre roll-off from the wheel which can lead to a crash or vehicle roll-over.

- If participants intend to use their own vehicle for training, they are sent attendance information prior to the course that outlines the preparation they should make prior to arrival.
- The vehicles supplied by Safe Drive Training during these programs undergo regular maintenance and safety inspections. A vehicle database and servicing schedule is maintained. Vehicles undergo a daily pre-start check and safety inspection. Only licenced mechanics are used for repairs and servicing (no servicing is done in-house). Some training vehicles are fitted with dual controls and all have on-board fire extinguishers.
- In-vehicle Monitoring Systems are installed into some vehicles which can be used to record in-car conversations or problems encountered during the training. They also trigger in the event of reckless driving or a crash to film the activities as a black-box recorder

- I confirm that SDT has prepared a venue database that covers all training location we operate at. This provides our instructors with emergency contact details for all local services (Police, Ambulance, Fire, Doctor, Hospital).
- Our instructors are trained and inducted into our company and operate under Standard Operating Procedures that are documented and supplied to all staff.
- Our instructors conduct a pre-course safety briefing for both the theory and practical sessions, when possible participants also watch a pre-course safety video which clearly outlines acceptable and unacceptable behaviours and the safety procedures in case of an emergency.
- Our instructors have Incident Report Forms and are expected to report on near-miss or any incident which may occur. These forms are kept in a database and instructors are supplied with copies to prevent future incidents
- SDT instructors operate under strict employment contracts which include Code of Conduct policies relating to sexual harassment/language/behaviour and at no times are permitted to be alone with nor touch a student.

ADDITIONAL INFORMATION

- Venues are chosen following comprehensive inspection and consultation to ensure they meet our training needs and provide a safe environment for participants and instructors.
- Photos of training venues and standard setup are included in our venue database for instructors to review.
- Venues are inspected before the commencement of each course, to look for potential hazards, obstructions and changes that may have occurred. If necessary training activities are modified to avoid new hazards.
- When bus transport is supplied for groups attending this program, we choose only reputable operators that supply seatbelt equipped buses.
- Practical outdoor training activities are terminated in bad weater. This applies if windspeeds exceed 50 km/h, temperatures drop below 5 °C or go above 38°C, for heavy fog, snow or during heavy rain or lightening storms
- SDT instructors are equipped with a tyre pressure gauge and disposable alcohol detector, which they are expected to have at-hand at all times. This allows them to check tyre pressures and also to conduct an alcohol test on any participant they suspect of being impaired.
- SDT has policies and procedure to remove or limit participation by any persons felt to be driving in a dangerous manner.
- Participants in the Safe Drive Test Drive program complete an enrolment form, confirming their licence is current and includes a Release & Indemnity Statement that highlights the activity they are undertaking has inherent risks.
- Physics in Motion Science Program: During the practical sessions of this program, students are where possible seperated from vehicles by a concrete wall. At venues where no wall exists, students are made to stand in a position which preceeds the area where the vehicle will manoeuvre. SDT staff maintain CB-radio links and can abort any demonstration. At certain times during the course students are asked to passenger in vehicles, to enable them to feel and measure the g-forces of acceleration, braking and steering. For one important demonstration conducted at less than 20km/h students do not wear seatbelts, at all other times students are required to wear a seatbelt.
- When participants ride as a passenger during demonstrations, vehicle speeds are restricted and the manoeuvres are conducted in safe areas. Seatbelts are worn, doors are locked and windows are closed.

IMPORTANT INFORMATION ABOUT INSURANCE COVERAGE

TO WHOM IN MAY CONCERN

Please find attached our new Public Liability Insurance Certificate. This expires on 15/11/24.

You will note we have moved our PL to the same provider as our PI cover. Our insurance broker advises this, since having separate insurance often leads to arguments between insurers over coverage.

It is becoming increasingly difficult to obtain PL insurance for our industry. Many insurers now decline to cover driver training due to their perception of risk or previous claims made by other training providers. Our company has never made a PL or PI insurance claim (during our 27 years in business) and yet we find it very hard to secure PL coverage.

Therefore when considering your venue hiring fees, please consider that training schools can be spending \$10,000 - \$30,000 per year to maintain the cover required to hire such facilities.

Therefore it is very concerning when we hear rumours of other driver training providers with inadequate cover or falsifying their cover. The most common trick being to arrange PL and/or PI insurance and obtain the certificate of insurance, then to cancel the insurance policy and obtain a refund of the fees paid. But since the venue does not check with the insurance company on a regular basis, they do not learn that cover was cancelled and the Certificate of Insurance provided to them is not worth the paper it is printed on.

Our legal advice is to fully disclose to you our PL insurance application wording, that outlines the activities we have declared to our insurer. As such our insurer believes our business activities are:

Driver Training including

- driver assessments
- junior driver training
- defensive driving
- advanced car control and skid pan training
- sports/performance driver coaching (including circuit training and drifting)
- 4WD gravel defensive
- 4WD off-road training

This means we are **not currently insured** for any activity not listed above.

There are some driver training providers who hold inexpensive PL/PI insurance which covers only incar training as conducted by learn-to-drive training schools. Since they have not requested or disclosed any other driver training activities they are actually not insured for other activities such as defensive driving, skidpan training or 4WD training.

If a training provider seeks to expand its services and run other driver training or even motoring or motorsport activities it needs to advise its insurer and check coverage will still be provided. It is believed that some driver training providers are conducting performance driving and motorsport events without the correct PL/PI coverage and this exposes the venue to liability, since the venue has allowed the activity to take place without checking the PL/PI certificates provided actually covers the activities being conducted.

It is very hard to obtain or very expensive to obtain PL insurance for motorsport and high speed driving. Often the entrant in such an event is unaware that their vehicle is not insured for the activity they have entered. Any activity that involves racing or high speeds with timing is not covered by vehicle insurance. Some insurers don't cover a vehicle for driving on a racetrack for any reason (even safe driving courses or programs).

For the sake of our industry, I urge you to review the PL insurance certificates of your venue hirers and to contact their insurer to ensure that they are aware of the activities the training provider is conducting and to do this on a regular basis.

Otherwise more insurance providers will see our industry as "high risk" and refuse coverage and all driver training businesses will be forced to close. Leaving your venue with no revenue from such activities.
