In addition, these countries have unique driving risks, such as:

- Low licensing standard and no formal driver education
- Vehicles and roads are often poorly maintained
- Basic Road Rules and limited penalties and enforcement
- Unsealed roads, steep gradients, tropical weather conditions
- Security risks from carjacking, robbery and compensation from accidents with valuable livestock

Everyday your workers are operating dangerous machinery (a motor vehicle) and doing so unsupervised. Just by being on the road, they put themselves, the company vehicle and other road users at risk.
